Treasurer	Richard Davies, Treasurer : The cash position is \$3.2 million and a little over \$2.1 million in the investment pool.	Update
Deeds	Beverly Bustin-Hatheway, Register of Deeds: Things are running smoothly; the staff has been doing what is necessary to keep the office clean and practicing social distancing.	Update
	We are up \$142K over last year.	Update
District Attorney	Maeghan Maloney, District Attorney: We have the court starting up more hearings; navigating those waters of being in the courtroom and needing to ramp up the number of people in the office. This is why we are now having the conversation about masks. Before, we didn't have enough people to bump into each other.	Update
	What the court is doing right now, is we have dispositional conferences on Tuesday and Thursday, and then any cases that were settled, we are doing three, Monday, Wednesday and Friday in addition to the in custody. The dispositional conferences are held all day. It's been great because we are settling a lot of cases and these cases do need attention. For July, we will have full in person arraignments, and the courts told me that they will have seventy- five people a day, so they will stagger the times. We will have twenty- five people coming in at 8:30; twenty- five at 10:30, and twenty- five at 1:00. We will wear masks, and the public will also be asked to wear masks. I think my concern is going to be if someone doesn't bring a mask, I would like to have one to give them; maybe not for the courthouse, but certainly for if someone comes here to the DA's office and they want to come in, but don't have a mask. PPE on a state level, some of it is hard to get, and some of it is easy to get.	Update
	Bob and I talked about the issue of supplying each county employee with two of those cloth masks. Through FEMA, we believe we can do that; I am a bit reluctant to say that we can take and give the masks to everybody who visits the county, as we only have so many of them. But we are more than willing to give up enough masks, two for each county employee. We have already started to give some out anyway.	Update
	Our big trade with the hospital today was, we traded them Hazmat boots for surgical gowns because the state cannot produce those at this present time.	Update
	Both of our planners are exclusively working from home; one is working on the Mitigation Plan, and the other is working on basically the going back to work plan that we are supposed to have on our shelf; we've never had one because we have never been in this type of position before.	Update
	There's an initiative out that FEMA wants to give each one of our facilities and the county that are storing large amounts of hazardous materials, they want us to give them cloth masks so they can return to work.	Update
